I have a plan that would cost 3 to 5 thousand dollars....I will know more about this as I check out a few options. I am not asking for all that money from boosters but if you want to get involved that would be great. I am working everyday on schedules for next year and all the stuff I normally do. Schedules should be finished soon....fall is completely done. Winter is 90 percent and next spring is 90 percent done. I do not know if school will start on time or what it will look like when we do start; I also have no answers about if sports will be played or when that might start. We also are not allowed to rent facilities right now so that is hurting the activities dept in terms of \$\$\$\$. I will not have any issues getting teams the basics for next year as far as equipment and uniforms. As far as stuff we would like to have I will need to hold off until I see what happens. Coaches have been in contact with kids on a regular basis and have done some neat things. Thanks for all you do.
