- Athletic Director's updates – New constitution for new conference (Trailblazer) must be presented next week to all superintendents; next school board meeting, Feb 24, will further discuss the football field and track renovation- estimated 1.8 million dollar cost to repair drainage and replace turf and track, if work begins in March there is a possibility of a discount but will affect Spring sports such as track and soccer; Girls wrestling and bowling are being sanctioned next school year; next senior night – both boys and girls basketball will be same day Feb 13
